Program Review

Tour of The Legends at Village West, Fashion, Dining and Entertainment

WOW what a place! We held our March 21st program at Dave & Busters at the Legends, Kansas City's newest shopping & entertainment experience.

Dave and Busters is sure to entertain folks of ALL ages! Our speaker was Amy Kraft of The Legends/RED Development. We also met and heard from Dennis McGovern, General Manger of the Legends. We learned several interesting facts about The Legends. The Legends shopping complex is 750,000 square feet and is actually one piece of the puzzle that makes up The Village West development area. The other pieces to the puzzle are Kansas Speedway, Cabelas, Nebraska Furniture Mart, Great Wolf Lodge and the T-Bones baseball complex. The overall theme for the Legends focuses on Kansas history, art, sports, political figures, innovation, adventure and exploration. The leasing demographic was a target consumer market of approx. 250 miles (considered a one day drive). The estimated number of consumers in this 250 mile radius is 55M. There are several points of interest to be taken in at the complex; the 150 foot smokestack and the 60 foot water fountain are just a couple. Some of the operations statistics are as follows: When operating at full capacity there will be 3,000 full & part time employees. Costs to maintain landscaping per year \$300K, housekeeping \$200K, snow removal estimated cost \$200K, and security cost \$600K. The overall operating budget is \$5M, taxes \$1.3M and sales tax generated is est. at \$19M.
